Standard for Review

Following Standards are under discussion with stakeholders for review:

Min TSS revision for:

- a) Synthetic Syrup for use in Dispensers for carbonated water (FSSR-2.3.23)
- b) Squashes (FSSR-2.3.21)

Revision in standards "2.10.8 Packaged Drinking Water (other than Mineral Water)":

a) Delinking minimum TDS 75 ppm for ingredient water used in beverages.

A presentation was made in November 2022 on the same and matter is under review of Scientific Panel on Water and Beverages.

CII submissions on FSSAI Notifications

Food Safety and Standards (Food Products Standards and Food Additives) Regulation, 2011

As part of this gazette, frequently asked questions (FAQs) dated 12.07.2022 were released providing clarity on the regulatory provisions for "Analogues in the Dairy Context" and use of dairy terms in the nomenclature of milk, milk products and other foods. The FAQs (No. 17) stated that the dimensions and colour scheme of the Milk Logo are being finalized and will be uploaded on the FSSAI website in due course of time.

In absence of clarity w.r.t. guidelines for the logo dimensions and colour. FSSAI issued direction dated 9th December 2022 stating extension of time-period for milk logo for a period of six months from the date of issue of such logo specifications by FSSAI.

In this regard letter was submitted requesting an extension of six months for implementation of the said order.

FSSAI Draft Notifications

FSS (Labelling Display) **Amendment** Regulations, 2022 related to Front of Pack Nutritional Labelling (FOPNL) and High fat, sugar, salt (HFSS) etc. dated 20th September 2022

Key issues and principal approach w.r.t HFSS definition, proposed categories, nutrients Threshold, exemption list etc. is under discussion. In this regard Joint association submission was made to CEO FSSAI on 22nd November.

As the next steps work is progress to review the algorithm with context to different food product categories

FSS Draft Notification of Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2022 dated 3rd November 2022

Comments on the draft from members on key issues w.r.t Colors, processing aids, standards for Indian mithais and Namkeen etc. Last date of submission is on Jan 2023.

Recent Orders / Directions

Clarification with respect to application for vegan logo endorsement dated 6th October 2022

It is observed that FBO's are applying for endorsement of vegan logo for multiple variants of the same product and two or more different products under single application.

In this regard, this order clarifies that in both the above cases i.e., same product with multiple variants and two or more different products, a separate application for each variant/different products needs to be submitted and the same will not be considered under single application. The payment also needs to be done separately with each application.

Clarification dated 20th October 2022 with respect to alcoholic beverages imported into India in bulk containers



Order states alcoholic beverages imported into India in bulk containers. It is informed that as per sub-regulation

1.3.9 of FSS (Alcoholic Beverages), Regulation, 2018, alcoholic beverage shall be packed in suitable containers as specified in the Food Safety and Standards (Packaging and Labelling) Regulations, 2011 now FSS (Labelling and Display) Regulations 2021 provided that bulk containers shall have no upper limit for alcohol content and shall meet the safety parameters of the product standards. Such products shall also carry a label declaring, "For Manufacturer of Alcoholic Beverages only".

Order dated 27th October 2022 regarding requirement of Health Certificate accompanied with the import of food consignment

The order states the requirement of Health Certificate accompanied with the import of food consignment. It states that Food Safety and Standards Authority of India has issued an order dated 3rd August 2022 and its subsequent clarification vide order dated 26th September 2022 on the subject cited above. In this regard, comments were also sought from WTO members, considering the comments received from the trading partners in respect of implementation time, it has been decided that the date of implementation of said order shall be extended by two months and the order will be now effective from 1st January, 2023.

Order dated 18th November 2022 regarding Rectifiable labeling information for imported food consignments

The order states with a view to facilitate ease of trade while ensuring the safety of food imported into India, based on the provisions under Reg 6(4) of FSS (Import) Regulations, 2017, it has been decided by the Competent Authority that all non-complaint labels on imported food consignment may be permitted for rectification at port itself.

This rectification must be carried out at Customs bound warehouses, before visual inspection or re-inspection by the Authorized Officer or his representative, by

affixing a single non-detachable sticker or by any other non-detachable method.

The Authorized Officer/his representative shall verify the label compliance during visual inspection and the consignment shall be subject to sampling and testing only if it is compliant with labelling requirements as per the FSS Regulations.

Direction dated 28th November regarding operationalization of FSS (Foods for Infant Nutrition) Amendment Regulations, 2022 relating to revise limits of Selenium, Manganese, iron and biotin

The order states with reference to the direction issued dated 29th March 2022 under section 16(5) of Food Safety and Standards Act, 2006 wherein revised limits of Selenium, Manganese, Iron and Biotin were specified in foods for infant nutrition, as relevant, and the transition period for the implementation of Food Safety and Standards Food for Infant Nutrition) Regulations, 2020 was extended up to 1st October 2022.

In earlier above said direction, limits of Selenium, Manganese, Iron and Biotin were revised in view of representations received from industry associations regarding difficulty in reformulating and manufacturing infant food products adhering to the levels of these trace elements.

BIS Submissions

BIS proposed Review of Indian Standard:

> 'Code for Hygienic Conditions for Production, Processing, Transportation and Distribution of Milk' as per IS 7005:1973.

BIS Submissions

- CII submitted inputs on IS 3633:2003 standard for Black tea w.r.t. definition of black tea and alignment of iron filings content with FSSAI.
- To align marking and wholesale package with FOOD SAFETY AND STANDARDS (LABELLING AND DISPLAY)



REGULATIONS. 2020 under clause 5.2 of List of Ingredients.

CII has been actively participating in meetings at BIS, some of key interventions are as below:

CII presented at the 20th meeting of FAD 9, scheduled for 15 November 2022 virtually at 1100 hrs.

In this meeting BIS decided

- Codex code of practice for the prevention and reduction of mycotoxins in spices is adopted as BIS standards and CII to recirculate for public inputs (2 Weeks timeline given) for commenting on the same.
- FAD 9/Panel - 1 Spices and Condiments Sectional Committee Oleoresins, the panel was requested to provide inputs in 4 weeks' time and the draft revision received will be sent in wide circulation for a period of 60 days.
- The committee decided to finalize the draft revision on FAD 9 Committee for Spices and Condiments:
- (i) Revision of IS 14216: 1994, Code for hygienic practice for spices condiments processing units.
- Revision of IS 1909: 1992, Indian curry (ii) powder - Specification.
- Spices and condiments Tamarind (iii) concentrate, Tamarind pulp, Tamarind powder and Dry kokum.



CODEX CONNECT

CII has been actively participating in meetings at NCCP India, some of key interventions are as below: -

Codex Coordination Group 9 - First meeting of Codex Coordination group (CG9) (Principles and Procedures) under National Codex Committee (NCC) to discuss agenda items of the 45th session of Codex Alimentarius Commission (CAC) was held on 9.11.2022 under the Chairmanship of Shri S. Gopalakrishnan (IAS), Chief Executive Officer, FSSAI

- through physical and virtual platform. Discussions were done and decisions were taken on each of the available agenda items. Some of the key takeaways from the meeting were:
- The members agreed to the provisional agenda items listed and the information provided by NCCP.
- Members were briefed about the status of the draft standards and related documents from the Codex Committee on Fats and Oils (CCFO) and Codex Committee on Food Hygiene (CCFH). The members deliberated on the standards and accepted their adoption.
- NCCP briefed about the draft guidelines for the Ready-To-Use Therapeutic Foods and informed that India's concerns were majorly addressed particularly on the preamble, importance of locally made available nutritious food. labelling and advertisements.
- Members were briefed about the draft standards and related documents from the Codex Committee on Fresh Fruits and Vegetables (CCFFV) and informed that India's concerns were addressed. Members agreed to support the adoption of the draft standard and related documents.
- NCCP elaborated on all the agenda items and related documents of the Codex Committee on Contaminants in Food (CCCF). India made reservations on the recommendations such as 0.1 mg/kg in case of lead in sugar. India proposal is 0.35 mg/kg based on the data. Also, the committee recommended 5ppb of aflatoxin in polished rice against India's proposal of 8ppb as per the data. Members agreed to support all other agenda items and to make India's reservations on the recommended levels again if India proposal is not agreed.
- Members were informed about the current status of the draft standards and related documents from the Codex Committee on Pesticide Residues. The representative from the Ministry of Agriculture raised concern on the revocation of the MRLs for the pesticide Chlorpyrifos. Based on the data shared by MoA, India may take a stand either for deferral or reservation on this pesticide.
- Members were briefed about the draft standards related to Codex Committee on Spices and Culinary Herbs (CCSCH).





- Members agreed to support the adoption of the same.
- Members were informed about the status of the deliberations on Zilpaterol. India to respond in the plenary according to the stand proposed by DAHD.
- India to support the proposals of new work on the standards of Kimchi as well as the amendment proposed on the standards of fruit juices and nectars and not to support in case of revision of the standards of milk fat based on comments received from NDDB.
- NCCP invited member's views for support of China for the co-ordinator for next term of CCASIA. The members accepted the same.

Circulations

Codex Committee on Food Additives (CCFA) and Codex Committee on Food **Hygiene (CCFH) -** CL 2021 /81 - FA was circulated with the members for information and comments on the priority list of substances proposed for evaluation by JECFA. Members were requested to submit comments on guidelines for the safe use and reuse of water in food production and processing. The comments received from the members were shared by CII.

CAPACITY BUILDING

CII has been working towards building capacity through various interventions. The highlights are as below:

- Capacity building on Food Regulations through awareness on compliance requirements for various regulations.

First Session of State Connect - Confederation of Indian Industry (CII) in association with Food Safety

and Standards Authority of India (FSSAI) and Goa Food and Drug Administration organized the first State Connect session at the Goa FDA Bhawan on 30th November 2022. She also mentioned that, while the government has taken significant steps in the area, it is imperative for all the stakeholders to utilize these opportunities to realise the full potential.
- Special training sessions on FSSAI's Hygiene Rating Program, responsible consumption of alcohol, and regulatory compliances for food business operations was conducted by experts from FSSAI and CII - FACE. The session was well received by the participants, and they expressed their interest in more such Connects in the future.


