Stage 1: Application

- **Receiving Application of Intent**
- Receiving filled application document from the applicant
- Preliminary screening of the applications

Stage 2: Physical On-site Assessment

- 3-4 days On-siteAssessment by the Trained Assessors (Comprising Consensus by assessment team)
- Calibration of Scores by a common Calibrator
- Review of Assessment Reports by a Reviewer
- Jury meeting to decide on winners (Applicant Unit to organize travel, stay and other miscellaneous expenses of the Assessors)

Stage 3: Awards Announcement and Feedback Reports

- Awards Ceremony
- Exhaustive Feedback report to all the applicants
